Thank you for your information request dated 3 April 2024. You asked for the following information:

"Pursuant to the Official Information Act 1982, I am writing to request information regarding the expenditure on Public Relations (PR) and Communications support by TPK. My request is detailed as follows:

Actual and Budgeted Expenditure:

Please provide a breakdown of the actual and budgeted expenditure on PR and Communications support for the current financial year, as well as the previous two financial years, for the TPK.

Procurement Process:

For each instance of expenditure on PR and Communications support, please indicate whether the services were procured through an open tender process or if it was a closed process. In accordance with the principles of the Official Information Act, I seek to understand the transparency and competitiveness of the procurement process.

Service Providers:

Please provide the names of the companies, agencies, or individuals that received payment for providing PR and Communications services to the TPK. Additionally, I request the value of the contracts awarded to each service provider.

The objective of this request is to gain a comprehensive understanding of the TPK investment in PR and Communications support, the processes by which these services are procured, and the entities that are engaged in providing these services."

Your request has been considered in accordance with the Official Information Act 1982 (the Act).

Questions 49-54 includes information on public relations and communications spend over the past five financial years.

Question 68 provides all spend relating to contractors and consultants over the past five financial years, of which some relates to public relations and communications. Details of these contracts including contract value and whether tenders were sought can be found in the Appendix J of the annual review.

Question 126 provides information on Covid related contracts, of which some relate to public relations and communication spend. Details of these contracts can be found in Appendix K of the annual review.

Contracts relating to public relations and communication spend not included in the annual review are listed in Appendix 1.

Te Puni Kōkiri adhere to government procurement rules as a mandated agency. Any spend over \$100k requires the use of an all of government (AOG) panel or must be openly advertised, unless the spend is outside the scope of the rules (rules 11 & 12) or an exemption is sought (rule 14).

I trust my response satisfies your request.
