Official Information Act request

Thank you for your information request dated 16 May 2024. You asked for the following information:

"I'm doing a research project and would like to obtain (ideally in excel), a list of funding given to organisations based in Taranaki from the Ministry in the last 5 years. I would like the table to include:

- The organisation's name
- Any categorisation of the organisation that the Ministry holds
- The purpose of the funding
- The year funding was given
- The funding amount
- The name of the Ministry fund it was given from."

Your request has been considered in accordance with the Official Information Act 1982 (the Act).

Te Puni Kōkiri publishes annually a list of investment recipients on our website. The recipients are listed by strategic priority, and then by fund and region. Currently, we have published lists of investment recipients for 2020/21, 2021/22 and 2022/23. This information is available on our website at: www.tpk.govt.nz/en/mo-te-puni-kokiri/corporate-documents/corporate-publications/investment-recipients

As the information you have requested for 2020/21, 2021/22 and 2022/23 is publicly available, in accordance with the Act we are refusing this part of your request under section 18(d).

In regards to the remainder of your request for funding granted in 2019/20 and the period 1 July 2023 – 16 May 2024, please refer to the attached excel spreadsheet for a list of investment recipients based in Taranaki. Details include the name of the fund, the purpose, and amount of funding granted. Names of individual whānau who have been granted funding are withheld under section 9(2)(a), to protect the privacy of natural persons, including deceased natural persons.

In making the decision to withhold information, I have considered the public interest considerations in section 9(1) of the Act.

I trust my response satisfies your request.
