- -Such as not attending the whole course but still getting a certificate."

On 29 May 2024 we contacted you to clarify whether you were only seeking information relating to Rebel Business School, or if you were also seeking information relating to their previous and/or current name. You responded on 29 May 2024 and clarified the scope of your request as follows:

Te Puni Kōkiri has granted funding to Popup Business School Aotearoa Limited, a previous company name of Rebel Business School. The below table provides the funding amount by financial year.

2017/2018	33160	Connecting communities through small business by way of a 10-day business course in Porirua providing business development skills, connecting with local business people and sharing their experiences. Participants will gain confidence and learn how to build a website, linking them with social media opportunities.	
2017/2018	43970	To deliver a 10-day business course in Te Tairāwhiti. Businesses will be involved in workshops to learn how to set up a business, build a website, and identify their target market. Participants will develop the confidence, skills and motivation for business start-ups.	
2020/2021	48297	To deliver 20 business workshops, across the Hawke's Bay region including attending a Trade Show and Graduation Event, in May 2021.

As part of the funding agreement, PopUp Business School Aotearoa Limited reported on the number of registered participants on their courses, rather than "total citizen completed certified", as you have requested.
